How does CoBiz Financial collect my personal information?	We collect your personal information, for example, when you:  Open an account or apply for a loan  Apply for insurance or file an insurance claim  Enter into an investment advisory contract  We also collect your personal information from others, such as credit bureaus, affiliates or other companies.	
Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only:</li> <li>Sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>Affiliates from using your information to market to you</li> <li>Sharing for non-affiliates to market to you</li> <li>State laws and individual companies may give you additional rights to limit sharing.</li> </ul>	
Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.  • Our affiliates include financial companies such as banks, insurance agencies, investment advisors and other financial service providers.	
Non-Affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.  • CoBiz Financial does not share with non-affiliates so they can market to you.	
Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you.  • CoBiz Financial does not jointly market.
