Affiliates	 Companies related by common ownership or control. They can be financial and non-financial companies. Our affiliates include financial companies such as banks, insurance agencies, investment advisors and other financial service providers. 		
Non-Affiliates	 Companies not related by common ownership or control. They can be financial and non-financial companies. CoBiz Financial does not share with non-affiliates so they can market to you. 		
Joint Marketing	 A formal agreement between non-affiliated financial companies that together market financial products or services to you. CoBiz Financial does not jointly market.
